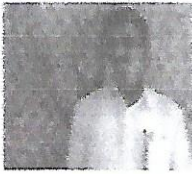

The assets, together with all further donations, contributions, membership fee, Indian and foreign grants, loan, profits and income thereof and the stocks, fund and properties representing the same shall be held by the Trustees upon Trust for the Objects and purpose and subject to power and provisions hereinafter set out.

For achieving any or all the hereinafter set out objectives the following means would be adopted:

- 7.1 To raise funds through donation/s, grant/s, gift/s, and contribution/s from individual/s, association/s, firm/s or institution/s.
- 7.2 To acquire by purchase/ lease/ mortgage/ gift/s / grant/s / legacy/ bequest/ exchange/s rights, privileges or otherwise from any person, company, society, trust, government/s, organization or body whatsoever, movable or immovable properties of all descriptions deemed necessary or useful for any purpose of the Trust.
- 7.3 To create, manage and maintain a corpus fund.

13. ACCOUNTS AND AUDIT:

13.1 Accounts of Trust:

The account of the Trust shall be opened anywhere of its operational areas by name of Trust "GREAT INDIA FOUNDATION, TRUST (TRUST)". Its account will be opened in any nationalized Bank/s or other Bank/s approved or in Post office or as permitted by the Board of Trustees for smooth functioning of the trust.

13.2 Operation of Account:

The joint signature of any two Trustees such as Chairman, Secretary, and Treasurer would operate the accounts. But the signature of the Secretary would be essential for its operation. In case of accounts being opened at different towns/rural/semi-rural/ urban/ metropolitan/ remote and other areas, the 'Board of Trustees' will decide of its nature and mode of operation.

13.3 Financial Year:

1st April to 31st March will be the financial year of the Trust

13.4 AUDIT OF ACCOUNTS:

The accounts of the Trust shall be audited every year by Chartered Accountant or a firm of chartered Accountants that will be appointed by the 'Board of Trustees' with the consultation of the Secretary. The audit of the accounts will be conducted by the Charter Accountant from anywhere of the nation.

14. FRAMING OF RULES AND BY-LAWS:

The Trustee may frame Rules and By-laws for the management of the Trust, its properties, institutions, personal staff and amend or rescind them as they deem fit and proper for the trust and keeping in view of the demanding concern of the society.

15. AMENDMENTS IN THE RULES AND REGULATIONS:

The amendment in any part of the Rules and Regulations will be made through 2/3rd votes of the 'Board of Trustees'.

16. LEGAL PROCEEDINGS AND ACTION:

The Secretary has authority solely to institute all actions and proceedings in the name and on behalf of the Trust and the Trustees and also to defend them in respect of all matters touching the Trust, its institutions, funds and properties. It shall not be necessary to join the other trustees in such actions or proceedings.

17. INDEMNITY:

The Trustees shall be chargeable only for such money, stocks, funds, deposit and securities as they shall actually receive not withstanding their signing any receipt for the sake of conformity, and shall be answerable or accountable only for their own deliberate or willful acts of omission or commission.

No Trustees shall be liable for any breach of trust committed by the co-trustees except in respect of his own act and in respect of any property in his custody.

29. ALLOWANCE TO TRUSTEE & OFFICE BEARERS:

If at any time any Trustee acts as a whole-time office-bearer of the Trust or renders any special service, the 'Board of Trustees' may in its discretion pay such remuneration or allowances to such Trustee as it may think proper.

21. DISSOLUTION:

In cases if becomes necessary to wind up or otherwise determine this Trust for whatsoever reason, neither the Author / Settlor Trustees nor his heirs nor the Trustees for the time being nor any other person shall have any manner of right over such funds of Trust or any other property. The net funds and other assets if any after meeting all liabilities will be handed over to any other similar Trust or Institution satisfying requirements of the Income Tax Act, 1961 and/or other laws applicable as may be decided by the Trustees subject further to the condition that it shall be so given to an institution or Trust as approved by the Commissioner of Income Tax or Secretary of Tax Exemptions or any other such authority as the cases may be.

22. UTILIZATION OF INCOME:

The funds and income of the trust shall be solely utilized for the achievement of its objects and no portion of it shall be utilized for payment to the trustees by way of gift, interest, dividend or whatsoever.

23. JURISDICTION OF COURTS:

The jurisdiction of court of the Trust will be Madhubani/ or and it will depend on the nature of matter.

24. INTERPRETATION:

The trust deed and the trust rules and regulation of the trust shall be interpreted by the Board of Trustees and their decisions shall be final and binding.
